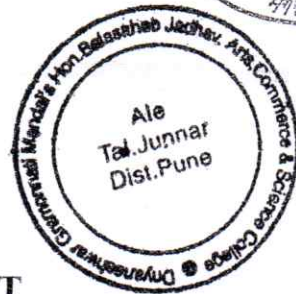

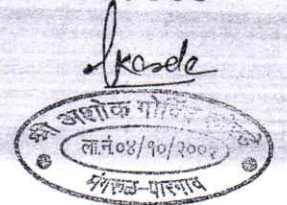

AND WHEREAS Agharkar Research Institute, Pune (Coordinator) and Dnyaneshwar Gramonnati Mandal's, Hon. Balasaheb Jadhav Arts, Commerce and Science College, Ale (Collaborators) are the organizations who have developed, over the years, expertise facilities in taxonomic and floristic research and have agreed to participate in the project as collaborators.

AND WHEREAS the Governing Body of RGSTC has approved the project for the financial support.

Now, therefore, in consideration of premises and mutual covenants hereinafter contained, the parties hereto agree as follows:

Scope of the Agreement: This Memorandum of Agreement (MoA) defines 1. The role and responsibilities of the participating agencies; 2. Financial agreement; 3. Monitoring and other matters related to the project - Digitized inventory of medicinal plant resources of Maharashtra.

1. ROLE AND RESPONSIBILITIES OF PARTICIPATING AGENCIES

1.1 Role and Responsibilities of ARI, Pune

- i. To provide funds to the extent of Rs. 1140570/- (Eleven lack forty thousand five hundred seventy) for a period of three years from the date of sanction of the project, to Dnyaneshwar Gramonnati Mandal's, Hon. Balasaheb Jadhav Arts, Commerce and Science College, Ale for undertaking activities as detailed in the project Annexure I subjected to the conditions as mentioned in para (2.2) of financial agreement.
- ii. To develop and manage database for freely accessible web base information, through data generated from the project.
- iii. Facilitate, coordinate and monitor the activities of the project for smooth functioning
- iv. Facilitate and ensure holding of meeting of all collaborators and Monitoring Committee for reviewing progress of project and take necessary steps to implement the decisions of Monitoring Committee for achieving the milestones, targets of the project.

1.2 Role and Responsibilities of Collaborating Organizations

- i. Undertake scientific and technical activities of the project as outlined in the project document and confirm to the outputs, milestones and targets.
- ii. Recruit all scientific and non-scientific staff as sanctioned under the project of RGSTC and as per ARI rules.
- iii. Maintain a separate audit head of account for the grants received from ARI for the project and operated by a designated and authorized accounts officer of the organization in consultation with the principal investigator of the project.
- iv. Ensure effective utilization of the grant given by RGSTC through ARI for the purpose for which it was granted and submit an annual audited statement of accounts and utilization certificate of the funds of project
- v. Ensure timely progress of project work and submit all periodical reports and other documents that would be required by ARI for monitoring the project progress.
- vi. Permit the ARI project Scientists or members of Monitoring Committee access to the work premises where the project activities is being carried out and provide all the information required by the committee
- vii. The manpower, both scientific and non-scientific, recruited shall be purely on contractual terms & conditions such that the contract for engagement of the manpower shall run concurrently with the said project period only.

2. FINANCIAL ARRANGEMENTS

- 2.1 The total sanctioned cost of the project is Rs. 3.02,91,460/-. The detailed year-wise and head-wise break up of financial support to individual organization is shown in Annexure II. The budget for the 1st year will be released by ARI initially. Release of next installments will be based on the progress of project and recommendations of the Project Monitoring Committee.

- 2.2 The participating organizations shall ensure that the funds of the project are utilized only for the project and as per agreement. Without approval of ARI/RGSTC the partner will not effect re-appropriation of funds from one budget head to other.
- 2.3 The project collaborators shall immediately refund any funds remaining unutilized on foreclosure or termination/completion of the project to RGSTC through ARI.

3. DURATION OF PROJECT

Duration of project shall be three years from the date the project has been sanctioned by RGSTC

4. RIGHTS OF OWNERSHIP / TECHNOLOGY TRANSFER AND UTILIZATION

- 4.1 The know-how generated from the project by Collaborators will be the joint property of Dnyaneshwar Gramonnati Mandal's, Hon. Balasaheb Jadhav Arts, Commerce and Science College, Ale (Collaborator) and ARI. It shall be the responsibility of all the collaborators and the ARI to take necessary action for protection of the intellectual property arising out of the PROJECT through proper instruments, such as, patents, copy rights, etc.
- 4.2 The know-how developed may be transferred to other entrepreneurs on a non-exclusive basis on such terms and conditions as may be determined by ARI.
- 4.3 All the assets including the equipment and produce acquired will be the property of RGSTC and shall not be utilized for purposes other than those for which the grant has been sanctioned. The rights of Dnyaneshwar Gramonnati Mandal's, Hon. Balasaheb Jadhav Arts, Commerce and Science College, Ale (collaborator) under this MoA shall not be transferred to any other party without prior approval in writing of RGSTC/ARI.

- 4.4 It shall be the responsibility of Dnyaneshwar Gramonnati Mandal's, Hon. Balasaheb Jadhav Arts, Commerce and Science College, Ale (Collaborator) to ensure that support of RGSTC is suitably acknowledged in the publications (papers, reports, etc.) arising out of the PROJECT.

5. SECRECY

It is hereby agreed that the participating agencies shall keep information and data collected completely secret provided that the right to transfer the technology shall rest with the RGSTC.

6. MONITORING

- 6.1 The progress of implementation of the project and proper utilization of grant shall be reviewed by the ARI and by the Monitoring Committee set up by ARI.
- 6.2 The periodic progress of physical achievements and the utilization of funds, statement of expenditure shall be evaluated by the Monitoring Committee.
- 6.3 The Controller and Auditor General of India, at his discretion shall have the right of access to the books and accounts of Dnyaneshwar Gramonnati Mandal's, Hon. Balasaheb Jadhav Arts, Commerce and Science College, Ale (Collaborator) for the grants received from RGSTC for this project.
- 6.4 The ARI may terminate the grant at any stage if it is convinced that the grant, has not been properly utilized or appropriate progress has not been made. In the event RGSTC terminates the grant, Dnyaneshwar Gramonnati Mandal's, Hon. Balasaheb Jadhav Arts, Commerce and Science College, Ale (Collaborator) shall hand over all documents including technical details and equipment purchased related to the project.

9. ARBITRATION

If the parties cannot agree on the appointment of the Arbitrator within a period of one month from the notification by one party to the other of existence of such dispute, then the Arbitrator shall be nominated by the RGSTC. The provisions of the Arbitration and Conciliation Act, 1996 will be applicable and the award made there under shall be final and binding upon the parties hereto, subject to legal remedies available under the law. Such differences shall be deemed to be a submission to arbitration under the Indian Arbitration and Conciliation Act, 1996, or of any modifications or reenactments thereof.
